In the absence of road construction, it was a lovely ride with the aspen trees donning their finest colors. On their return trip, many riders were caught in a hailstorm near Pine Junction... yet another reminder to enjoy the good moments while we have them.

Logistics

Sept. 26, 2009: Begin assembling early in the South Parking Lot at Columbine High School (6201 S. Pierce St. Littleton, CO 80123). Around 10:00 a.m., some people you might know will say a few words before a balloon launch. Balloons will be launched in memory of the lives lost violently in American schools. Bikes begin leaving Columbine at 10:30 a.m. and ride to Platte Canyon High School (57393 U.S. Highway 285, Bailey, CO 80421). The distance is approximately 37 miles.

Your participation is an honor to us and our community. Though Emily's Parade is a fundraiser for The "I Love U Guys" Foundation, there is no requirement to pay. The suggested donation to register for this event is \$20 per rider. Generous donations from participants and onlookers are distributed responsibly and effectively toward the stated goals of The "I Love U Guys" Foundation.

WAIVER AND RELEASE OF LIABILITY AND INDEMNITY AGREEMENT

PLEASE READ THIS DOCUMENT CAREFULLY. BY ACCEPTING THIS AGREEMENT YOU ARE WAIVING CERTAIN LEGAL RIGHTS AND YOU ARE RELEASING THE SPONSORS, PROMOTORS, BENEFICIARIES, AND EVENT MANAGERS OF EMILY'S PARADE FROM ANY AND ALL LIABILITY.

I hereby waive, discharge, and release the sponsors, promoters, beneficiaries, and event managers of Emily's Parade (hereinafter, the "Parade") and any and all individuals employed, contracted by, associated with or assisting in the production and management of the Parade (hereinafter the "Indemnified Parties") from and against any and all liability they have or may be determined to have, whether caused by their negligence or otherwise, concerning any injuries or damages of any kind that I may suffer from my participation in or related to the Parade, including but not limited to, physical or mental injuries, death, medical expenses, and property damage.

This Waiver and Release of Liability and Indemnity Agreement (hereinafter "Release and Indemnification") shall apply to and be binding upon my heirs, personal representatives, and assigns and any other or individual or entity acting on my behalf, or acting through subrogation.

I understand that the Parade is an event involving my use of a motorcycle. I am aware of the risks inherent in the use and operation of motorcycles and motorcycle equipment, and understand the risks associated with participating in motorcycle riding events such as the Parade. I am relying on my own judgment in assuming all risks of injury and damage and agreeing to indemnify and hold harmless the Indemnified Parties as stated in the foregoing.

This Release and Indemnification is intended to be as broad and inclusive as is permitted by the laws of the state of Colorado. If any portion of this Release and Indemnification is held invalid or unenforceable, it is expressly agreed that the remaining provisions shall continue in full force and legal effect.

If signing as a parent, guardian or agent on behalf of a minor participant, I certify that I have the actual authority to sign the Waiver on behalf of such minor. I also understand and give permission to the Indemnified Parties to use my name or images of my participation in this Parade for publicity or promotional purposes, without liability or obligation to compensate me. By providing my email address, I give permission to the Parade and its owners to communicate with me via this method. If after the Parade, I wish to remove my email address from the Parade's list, I will be able to do so.

I have read, understand, and do voluntarily agree to all of the terms of this Release and Indemnification and specifically state that no representations, statements, or inducements have been made to encourage my participation in the Parade.
